Hope Builders provided 87 accessibility solutions and home repair projects to 73 clients in the greater Kansas City metro area. The projects completed included 41 ramps or walkways, four bathroom upgrades and numerous accessibility modifications and minor home repairs. Work was done primarily in Jackson County, Missouri and Johnson and Wyandotte counties in Kansas but also included one project in Leavenworth County, Kansas. Work was performed by 258 volunteers who contributed over 7,000 project hours. Volunteers were comprised of regular HopeBUILDERS as well as those from eight different partners. There were 41 ramps constructed throughout the KC metro area, including one ramp in Leavenworth. Ramps ranged from a few feet to 160+ feet in length. Funding for specific projects was provided by The Whole Person (8 projects), The Home Depot Foundation (2 projects) and Variety KC (1 project).
